## From the Chairman



Dear Friend,

The time since we brought out Priyadarshni's first Newsletter in September has been a busy one for the Academy. The Newsletter was released most appropriately in the hands of Dr. Vijay Khole, Vice Chancellor of Mumbai University, at a function Priyadarshni organized to render financial assistance to students affected by the disastrous floods in Mumbai. The program was part of Priyadarshni's first-priority objective of advancing the cause of education. The program itself was memorable as well as poignant. As many as 287 students received financial assistance ranging from Rs.500 to Rs.5000 totaling Rs. 2,05,500. Dr. Khole, who was Chief Guest at the program, observed during his speech, "Priyadarshni Academy is the first social organization to provide financial assistance to a flood-affected educational cause". Dr. Mrs. Rupa Shah, Vice Chancellor of SNDT Women's University, lauded the Academy for rendering assistance to "women students" who formed a majority of the recipients of assistance.

Our first training program was inaugurated during the last quarter when a program on "Mind Management for Success" was conducted. The program was a significant success and an extension of Priyadarshni's same priority theme, Education. We plan to do more training in the future and hope that we can help in the cause of training people for a fast-globalizing India.

In the same breath, we had a panel of educational experts examine the impact of WTO's GATS on the Indian educational system and did our bit to nudge authorities to do more to spread awareness and take rectification action.

We are gearing up, in the coming months, for many more useful activities. First on the cards is the "National Integration through Dance and Music" Programme on January 20 which will focus on dance. Dance groups for the programme and the presentation of pieces have already been selected. Next in line will be the 22<sup>nd</sup> Anniversary Educational Scholarships and Literary Awards programme in March. The deadline for receiving applications for scholarships was December 31, 2005 and the large number of applications received will be whetted by the Priyadarshni office and selections made by the Educational Scholarships Committee well before the date of the presentation function. Scholarships will be given in the areas of engineering, IT, medical sciences, education, and architecture. The additions this year are three

scholarships of Rs.10,000/- each, two in architecture and one in civil engineering. These will be named as "Khemchand B. Kothari Scholarships", money for which was kindly donated by Mr. Ashok Kothari, Partner, Gokul Associates.

Following up on the success of the book, "Kautilya's Arthashastra-Its Contemporary Relevance", we convened a meeting of experts to discuss a prospective successor publication. Initiatives on this project are continuing and we hope to bring about greater awareness of the wisdom of Kautilya among the general public.

Last but not the least, we are well into the long process of selecting international and national awardees to be honoured at the prestigious biennial Global Awards Function to be held at the Regal Room of Hotel Hilton Towers in Mumbai on September 19, 2006. There will be some renowned figures coming, well worth the long wait.

I am sure you would like to be part of some or all of these events. Have a Great 2006 and be with us as often as you can.

## Priyadarshni Academy "First Social Organisation to Give Financial assistance to an Educational Cause" says Mumbai University Vice Chancellor

Priyadarshni Academy, as part of its educational assistance programme, gave financial assistance to 287 flood-affected students at a function organised by the Academy at the Walchand Hirachand Hall of the Indian Merchants' Chamber on September 1, 2005.

Dr. Vijay Khole, Vice Chancellor, University of Mumbai, was the Chief Guest and Prof. (Mrs.) Rupa Shah, Vice Chancellor, S. N. D. T. Women's University, was the Guest of Honour. Mr. Daniel Zohar Zonshine, Consul General of Israel, Mr. Ashok Patil, former Minister of Maharashtra, and Dr. Ms. Indu Shahani, Principal, H. R. College of Commerce & Economics, gave away the cheques to the students.

Speaking on the occasion, Dr. Vijay Khole, Vice Chancellor, University of Mumbai, stated that Priyadarshni Academy "is the first social organisation to give financial assistance to a flood-affected educational cause" and added that others should take a cue from this organisation".

Prof. (Mrs.) Rupa Shah, Vice Chancellor, S.N.D.T. Women's University, complimented Priyadarshni Academy for extending financial assistance to 154 flood-affected girl students. She recommended that Priyadarshni pursue such noble educational assistance programmes.

In his welcome address, Mr. Rupani stated that out of the 287 students, 24 applied directly and the rest were recommended by schools and colleges from the flood-affected areas. Financial assistance ranging from Rs. 500 to Rs. 5000 to each student and totaling a sum of Rs.2,05,500 was disbursed on the occasion.

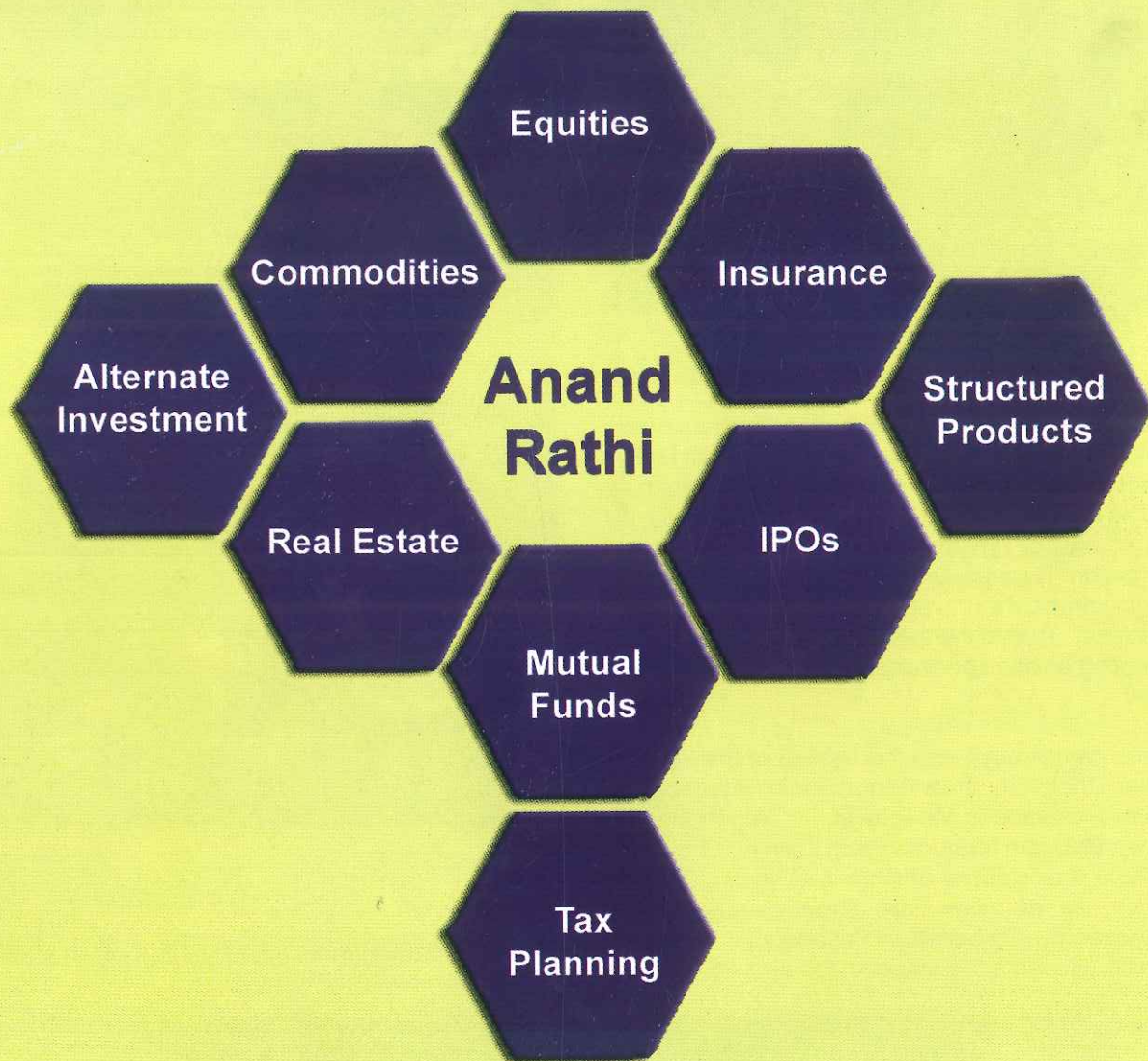

## High-powered political leaders requested to take note of the "IMPLICATIONS OF GATS ON INDIAN EDUCATION"

Priyadarshni Academy presented a note in October 2005 on the "Implications of World Trade Organization's General Agreement on Trade in Services on Indian Education" to Maharashtra Chief Minister Shri Vilasrao Deshmukh, Maharashtra Minister for Finance and Planning Shri Jayantrao Patil, Maharashtra Minister of Higher & Technical Education Shri Dilip Walse Patil, and President of the BJP in Maharashtra Shri Nitin Gadkari. Priyadarshni expressed the hope to some of the political leaders that the issues covered by the note would be taken up further through appropriate fora.

Priyadarshni had formed a panel of educational experts in August 2005 because of its concern for the issues that GATS was throwing up. The Committee met on August 11, deliberated on the issues threadbare and made recommendations. Relevant texts of the note presented are reproduced below

### Background :

WTO's GATS includes education as one of the services for free global trade.

At the end of the year 2000, the volume of global trade in education had been estimated at 50 billion dollars with an annual growth rate of 10-12%.

The free trade scheme envisaged under GATS will guarantee that academic institutions or other education providers would be free to:

1. Export and import degree, diploma programs
2. Award degrees, diplomas, and certificates with minimal restrictions
3. Invest in overseas educational institutions
4. Employ instructors for their foreign ventures
5. Set up educational and training programs through branches, franchisees, distance, and online learning technologies

WTO expects that free trade in education will confer benefits to participating countries, especially developing countries like India, where the level of enrolment in education is much less than that even in middle-income countries.

Entry of foreign institutions will add to the supply of seats and improvement in the rate of enrolment.

The resource allocation for education in India stands at 3.5% of GDP, far below the desired 6%.

As state-funded institutions are largely exempted from the

education is state-funded, the impact of GATS will predominantly be on Indian higher education. Even higher education in India is largely under the control of the government due to the dependence of institutions on government aid. While very little foreign institutional collaboration will come in professional education, as our fee structure is very low, it is, therefore, primarily in the area of technical education that Indian institutions will be affected.

GATS may help institutions shake off government control and offer innovative programmes in keeping with the changing times. This could pressurize the Indian government to liberalize the educational system.

**The Indian government is formulating regulations for the entry of foreign institutions and is taking care to ensure that indiscriminate entry is prevented.**

### Committee's Observations:

The Indian education system per se is not poor. It has been made poor because of excessive government controls and poor academic leadership at different levels. The result has been:

- Lack of competition
- Paucity of good teachers
- Outdated curricula
- Theory-oriented education
- Parallel education in the form of coaching classes

The entry of foreign players, which is mushrooming, will serve as good competition forcing the Indian government to liberalize.

New private providers may offer only education which is determined by market forces and devoid of any social contents. This can have disastrous long-term consequences for our nation and our national values. The university may no more be able to contribute to national development and strengthening of civil society.

### Committee's Recommendations :

India should exploit the opportunity provided by GATS to take its education abroad and get a sizeable chunk of the monies. With this in view, areas which will attract foreign students both for Indian education abroad and for education in India should be identified. Investment in infrastructure is an essential ingredient to give India a pride of place in the globalizing educational scenario.



The theory-oriented system should be de-emphasized. Programs and curricula should be evolved which provide for a direct linkage between education and industry, as the primary aim of education is to lead students to a career and to career growth.

The outdated curricula should be brought current.

Indian universities should start innovative programs a la IIMs for different audience groups and convert the universities into self-sufficient institutions. The IIMs have been highly successful in organizing short-term programs for political

leaders, public administrators, public sector units, etc.

## Arthashastra - Its Contemporary Relevance

### 'A Must book for everyone'

Nothing vindicates belief better than reality. Two thousand four hundred years ago, Kautilya compiled the Arthashastra and with it he proved to be a king-maker as he enabled the inception of the Gupta dynasty. The Arthashastra endured the test of time and it has since withstood the test of credibility.

When a thinker demonstrates vision and foresights, it is crucial and extremely useful to understand the elements of this thought that has present applicability. We will be enriching ourselves if we learn and grasp even a fraction of the wisdom that Kautilya embodied. This is a treatise that encapsulates in many ways even the complexity of our current world. The problems that existed then persist in a more widespread and magnified manner in the contemporary world.

Herein begins the relevance of studying the Arthashastra. Kautilya demonstrated an extremely vital imperative: governance, polity, politics and progress have to be linked to the welfare of the people. Interestingly, closer to recent times, Abraham Lincoln said, "Democracy is for the people, by the people and of the people." The Arthashastra's resonant theme holds even truer today and it is the upholding of this principle that stands at the core of attaining development.

Kautilya's Arthashastra is a masterpiece dealing with varied aspects of governing a monarchy, such as administration, taxation, law, diplomacy, business and trade, agriculture, labour, society, etc.

When he was President of the Indian Merchants' Chamber, Mr. Nanik Rupani had the good fortune to undertake the publication of this book with the support of the Indian Merchants' Chamber Economic Research and Training Foundation and with financial assistance from Hinduja Foundation.
